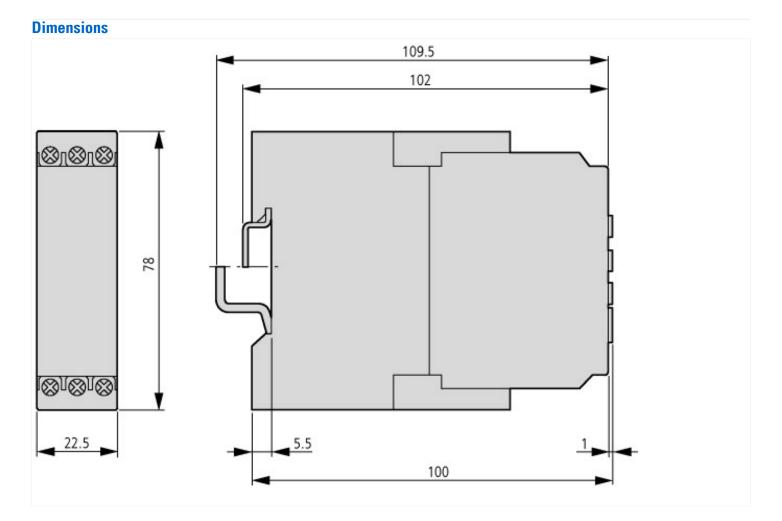


AC load (resistive)
